The Board and Ohanian discussed creating a scope of work, which will be brought back to a future meeting. Tom Weddle, General Manger, Crestline Village Water, asked about any future usage of water in the community, and if Hesperia Venture 1 would have first rights. The Board said there will be no minimum requirement of quantity, but currently the District's water cannot be used on the mountain, since it is not tertiary.
