## **Construction Meetings:**

Management continues to attend meetings every two weeks with Pacific HydroTech, Webb, and Dudek. The last meeting was held on October 27, 2022. (PowerPoint)

## Financial Reporting:

Now that the construction progress is moving along the invoices from the contractor are starting to come in higher. Management has moved \$1m from its' Reserves to the General Checking account and has already used that money to pay September invoices. As per item 6 on the Agenda, Management feels it would be in the District's best interest to prepare to move more money.

We contacted California Bank & Trust and asked for information about GAP Loans; cost, time frame, and amounts. Their Prime is approximately 7% and would take only about a week to receive.

We spoke to Bruce Snow at Zions Bancorporation to see if any bonds had matured. He informed us that one in the amount of \$1.6m had. We asked that he not reinvest it in case we needed it.
