### SUBJECT: PURCHASE OF A NEW FORD F250

#### A. RECOMMENDATION

I am recommending the purchase of a 2024 Ford F250 in an amount not to exceed \$75,000.

#### B REASON FOR RECOMMENDATION

With the surplus of two vehicles the District will be down at least one truck. This truck will replace the diesel F250 subject to surplus. This truck will not be a diesel.

# C. FISCAL INFORMATION

Ford opens up time frame to be able to order for the next year and the window is now open to be placed on the list. This window is generally open for two to six weeks, depending on the number of orders. The window to be placed on the list is now open. Payment and delivery will likely be in December 2024. For fiscal year 2024/25 in the CIP budget line, an amount of \$75,000 for one vehicle is set aside for vehicle replacement. The cost to purchase this truck is \$70,041.94.
