

SAFETY PYRAMID



<u>Engineering controls:</u> First and best line of defensive for protecting employees from injury.

<u>Administrative controls:</u> Standard Operating Procedure's (SOP's) that instruct employees how to safely perform a job.


<u>Personal Protective Equipment:</u> (PPE) Specific protective equipment provided to the employee. PPE does not eliminate the need or replace Engineering or Administrative controls.

<u>Incident:</u> An incident is any departure from acceptable standard procedure. For example, welding near flammable liquids is an incident.

<u>Hazard:</u> A hazard is an incident without proper controls applied. For example, a puddle of oil on the floor is a hazard.




HIERARCHY OF HAZARD CONTROL
