**SUBJECT:** SLIP LINING AND MANHOLE REHABILITATION

### A. RECOMMENDATION

I recommend to award the contract to Sancon Technologies, Inc. for Phase 9 for Slip Lining and Manhole Rehabilitation in the amount of \$186,513.00. Work is not anticipated to begin until October or September 2023 due to extreme ground water conditions.

### B REASON FOR RECOMMENDATION

Sancon has unique and specific knowledge of the District's sewer lines, and have worked in the mountain terrains. The Slip Lining is part of the District's on-going efforts to improve its aging wastewater collection system infrastructure, manage Infiltration and Inflow (I&I), as well as to comply with the State mandated SSMP (Sewer System Management Plan) and the NOV (Notice of Violation). Minimizing Inflow & Infiltration is a critical element of the District's Strategic Plan to meet the District's S.W.R.C.B. (State Water Resources Control Board) Waste Discharge Requirements.

### C. BACKGROUND INFORMATION

Under all but the most extreme wet weather conditions, the District's collection system meets and exceeds Regional Board standards. However, under extreme wet weather conditions I/I in the District's collection system does not always meet these standards. More specifically, flow discharges from the District's Wastewater Treatment Plants to the Las Flores Ranch occurring during extreme wet weather conditions can exceed plant flow design rates and greatly increase the opportunity for an SSO (Sanitary Sewer Overflow). These discharges can occur during extreme and prolonged wet weather conditions, and there is concern that an adverse rain season is predicted.

### D. OTHER INFORMATION

On October 14, 2021 a unanimous vote by the Board approved Sancon Technologies (sole bidder) to perform Phases 8 and 9.

### D. FISCAL INFORMATION

For Fiscal Year 2022-23 the District budgeted \$260,000.00 for NOV items; Slip Lining, Manhole Rehabilitation, Flow Monitors, and Weather Stations.


