SUBJECT: NEW UTILITY SOFTWARE FOR BILLING

A. RECOMMENDATION

I am recommending that the District cancel its' services with Muni-Billing, which is not under contract, and approve the new quote for software subscription with Creative Technologies.

B REASON FOR RECOMMENDATION

Muni-Billing has reached out to inform us that our account cost will be rising from \$781.86 quarterly to \$2,400.00 quarterly.

C. OTHER INFORMATION

I have reviewed three different companies. I looked at their services, costs, and contacted other users. I have found that many original customers are turning from Muni-Billing to Creative Technologies. The account manager we have been assigned to worked at Muni-Billing previously and helped with that installation and support, making him familiar with what our needs are.
